Will Cotey is in Wausau where he will undergo an operation.

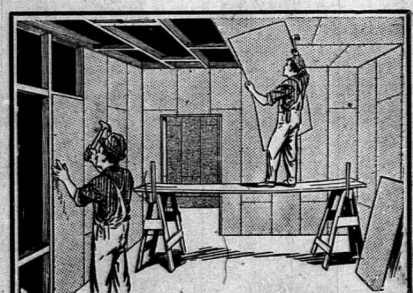
